Using This Revisable PDF Form

Any person who has had their driver's license revoked by the Department of Motor Vehicles (DMV) following the conviction of a third offense of driving under the influence within ten (10) years or conviction of involuntary manslaughter while driving under the influence or maiming while driving under the influence may petition the circuit court where he or she lives to restore his or her privilege to drive. Va. Code § 46.2-391.

The period of time which must elapse before such person may petition to have his driving privileges restored or a restricted license issued varies based on whether the person is requesting restoration of his or her privilege to drive or a restricted license to drive to certain locations. For restoration, five (5) years must have elapsed since the date of the last conviction and the person must be required to install an ignition interlock system for at least six (6) months. In lieu of restoration, the court may also order a restricted driver's license be issued. To request a restricted driver's license, at least three (3) years must have passed since the last conviction unless your last conviction resulted from a final order being entered after the successful completion of a Veterans Treatment Court Program, behavioral health docket or other specialty docket established pursuant to Va. Code § 18.2-254.2 or § 18.2-254.3 or Rule 1:24 of the Rules of the Supreme Court of Virginia. The person must also be required to install an ignition interlock system for the duration of the restricted license. Va. Code § 46.2-391(C). The petitioner must indicate what he or she is seeking by choosing either option A or option B.

A certified copy of the petitioner's DMV record should be attached to the completed petition.

The court, prior to acting on the petition, must order an evaluation of the person by VASAP.
